COMMENTARY

- **Regarding Points.** Where there not a stated point value, MCL 257.320a is silent to an assigned point value for the particular offense, whereas, where there is a zero ("0"), MCL 257.320a expressly states that no points should be assigned.
- **Note the Lack of Civil Infractions.** This chart includes only misdemeanors and felonies. No civil infractions. Driver responsibility fees can be assigned for first-time civil infractions as well – they are just not listed here. The above offenses will hopefully not be pled to civil infractions.
- **Commercial Drivers.** See MCL 257.319b specifically deals with offenses committed by commercial drivers, both CDL and Chauffeurs. This section deals with many offenses that are incorporated from the CFR (federal law). Consult MCL 257.319b and the relevant CFR sections when concerning violations of law committed by commercial drivers.
- **Regarding multiple offenses in one incident.** Note that suspensions arising out of the same "incident" are punished only on the basis of the offense with the longest period of suspension, i.e. the SOS cannot stack suspensions. See MCL 257.319(13).
- **"Prior Conviction" Defined.** See MCL 257.319(19)-(21): note how the definition of "prior conviction" is very broad, prior violations of municipal ordinances and statutes of other states that are substantially similar to the statutes in MCL 257.319 are considered "prior convictions." If there are any issues regarding prior convictions, check these subsections specifically, as there are exceptions to this general rule.
